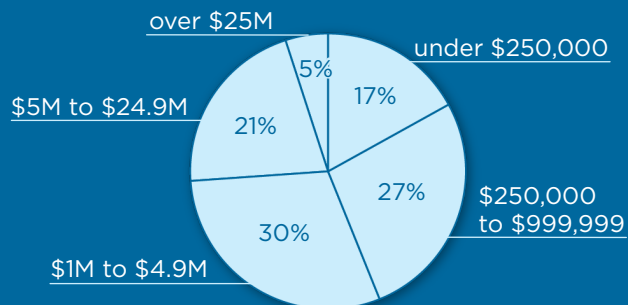

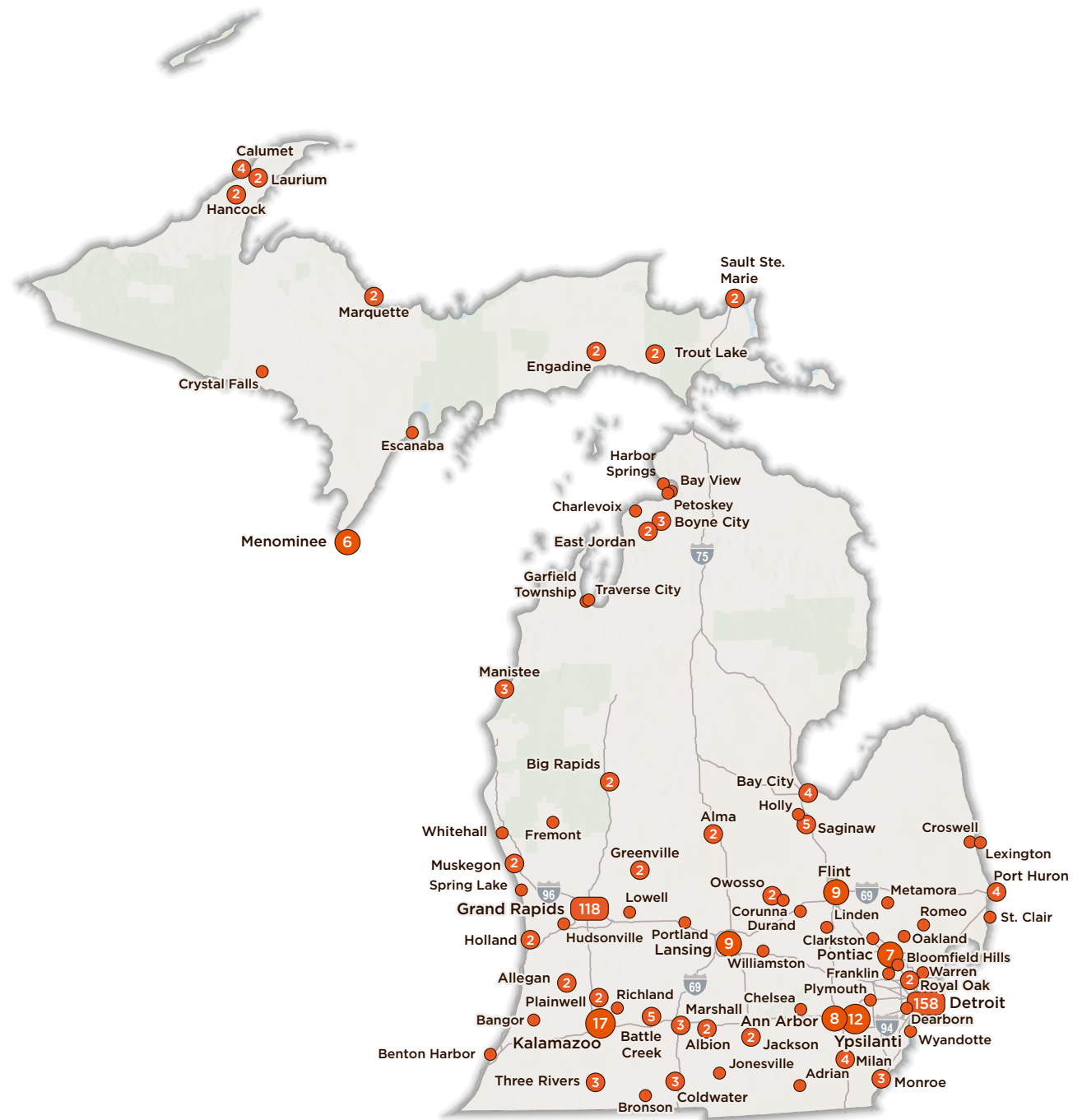
## NATIONWIDE HTC INVESTMENT BY PROJECT SIZE<sup>†</sup> - FY22
