#### Answers to Questions

1. The RFP mentions strategic plans and business plans. Which is the desired product as both are robust planning tools requiring significant time and resources?

ANSWER: A strategic plan and a business plan are both desired. The approach envisioned is to work with the sites to develop a strategic plan for their programmatic visions. Once the strategic plan is developed, a business plan would be developed to outline the feasibility of the programmatic vision and operations related to the nonreligious mission of the site.

2. Please confirm that the RFP includes strategic plans, training, and workshops for 6 Black churches, and capital feasibility plans for those same 6, plus 4 more churches; so the final total of capital feasibility studies is 10.

# ANSWER: The total number of Black churches is 6. Of the 6 church sites, 4 are in Alabama, 1 is in Chicago and 1 is in Los Angeles.

3. Whether an 18 or 24-month timeline, do all efforts need to be complete by the 1<sup>st</sup> quarter of 2026?

## **ANSWER: Yes**

4. Under attachments, please confirm that the MWBE Subcontracting Plan and the Execution of Officer are the only attachments required with the proposal, and that Exhibit A - STANDARD SERVICES AGREEMENT is not required.

## ANSWER: The Standard Services Agreement is an example and not required.

5. Please confirm that we should only reference standard service agreement in the proposal if there are standard service agreement terms that we want to modify if awarded the contract.

# ANSWER: Yes. Note that the offeror awarded a contract shall have an opportunity to comment on any draft contract and its terms and conditions.

6. For MWBE firms, if the subcontracting firm is MWBE and was the only firm requested by the prime (also an MWBE) must we still list other MWBE firms that might have been contacted? Can additional MWBE contractors be listed who are not formally certified, but are MWBE sole proprietors?

# ANSWER: A comprehensive statement regarding contractor's and subcontractors' status as an MWBE, without regard to formal certification, is acceptable.

7. Under "2. Requirements for Proposals", letter "E" is "Criterion Five..." and "F" is "Criterion Nine...". Were Criterions 6,7 and 8 intentionally omitted?

ANSWER: This is a typo – nine should be six.
